In order to prevent and contain the spread of 'COVID-19', it has been decided that entry of people to all units under this Department, where large congregation may take place, would be strictly regulated.

It is accordingly ordered that:

1. All Zoos and similar establishments under the control of the Forest Department shall remain closed;
2. Visitors shall not be allowed in the Wildlife sanctuaries and National Parks under the control of the Forest Department; and
3. All eco-tourism projects and lodges will not allow guests/visitors. Suitable steps may be taken for cancellation of bookings and refund of the amount if already paid.

The above shall be with immediate effect and until further orders.
